Now More Than Ever

ur 35th anniversary year began with excitement for new programs GSBA was launching. Our membership had never been stronger, more robust and growing daily. GSBA and the U.S. Small Business Administration co-sponsored the first Seattle Business Builder event which showcased small LGBT owned businesses. King County Executive Dow Constantine announced that the County would recognize LGBT Certification, making it the first government entity in Washington State to recognize and include LGBT certified businesses in their diverse supply chain. In partnership with GSBA, the Puget Sound Business Journal published the first ever edition showcasing the top 25 LGBT owned businesses which was announced at the Business of Pride event at the Paramount Theatre. It was a spectacular kick-off to Pride month.

Unfortunately, the excitement around the new economic opportunities was marred by a nationwide attack against our trans community. In Seattle, anti-trans organizations introduced several pieces of legislation which would have left our transgender family unprotected and vulnerable to attack. Fortunately, GSBA and a large consortium of nonprofit organizations came together with our legislative caucus and successfully prevented any hate legislation from becoming law. Our opponents then starting an initiative drive but the LGBTQ and allied coalition was ready and crossed the state educating people about who was really at risk and why discrimination against any one group threatened the safety and civil rights of us all. Washingtonians came through and the initiative never made it to the ballot.

GSBA Takes a Leading Role in Defending the Civil Rights of the Trans Comunity

ix bills attacking the transgender community were introduced in the Washington State Legislature in 2016. Through intense efforts by the LGBT community and our allies, only one bill came up for a vote, and was subsequently defeated by a vote of 25-24, with three Republicans joining most Democrats in opposition. GSBA was a founding member of the **Washington S.A.F.E. Alliance** to fend off these anti-trans bills, working with the coalition's lobbyist in Olympia.

After failing at the Legislature, opponents of equality then filed Initiative 1515 which aimed to take away basic nondiscrimination protections for transgender Washingtonians. GSBA organized and led the business coalition within the Washington Won't Discriminate campaign against I-1515's attempt to roll back our 10-year old LGBT civil rights laws. Hundreds of our businesses of all sizes signed on to support Washington's existing and critical protections, loudly proclaiming that equality is good business. In part due to the strong messaging from the business community, I-1515 failed to qualify for the ballot!







Standing Up For Your Right to Make Decisions

Supporting everyone's rights to make decisions about their own bodies has always been central to LGBT civil rights, and attacks on women's health are being waged for the same reasons and by the same people who oppose LGBT rights. Supporting a woman's right to choose has been an explicit platform in GSBA's legislative agenda for years, and your response to the call to action was inspiring! Like with marriage equality, GSBA led the business community in an amicus brief of business leaders to the U.S. Supreme Court in the Whole Woman's Health v. Hellerstedt over a law meant to outlaw abortion in that state. The Supreme Court struck down the law, agreeing with many of the points made in our amicus brief in their decision.

King County Creates History in Recognizing LGBT Certification



Ethnic Chambers Invite GSBA to Join Coalition



SBA and the Ethnic Chamber of Commerce Coalition (ECCC) were jointly awarded a \$285,000 grant by the Seattle Office of Labor Standards to do business outreach and education around the city's labor laws. This coalition includes the Seattle Chinese Chamber, Seattle Vietnamese Chamber, Filipino Chamber, Korean American Chamber of Washington, King County Hispanic Chamber, Taiwanese Chamber, India Trade Relations Committee, Business Impact Northwest, OneAmerica, Cascadia Consulting, and the Eritrean Community in Seattle organization. GSBA was honored to be formally asked to join ECCC to further their work in raising the voices of small, minority, and immigrant businesses in the region.

Success at the Ballot Box

Every ballot measure endorsed by GSBA in 2016 passed. This included expanding the Seattle Housing Levy, funding a comprehensive regional mass transit system (**Sound Transit 3**), creating **Emergency Risk Protection Orders** (1-1491), and raising the statewide minimum wage and implementing paid sick and safe leave (I-1433). 
